## PRIVACY STATEMENT

Himmelwright, Huguley & Boles, LLC is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Himmelwright, Huguley & Boles, LLC Web site and governs data collection and usage. ### Collection of your Personal Information
